TRESPASS NOTICE INFORMATION

CNI lwi Holdings Limited (CNI)

- 1. CNI holds the land under Kaingaroa Forest in trust on behalf of the beneficiaries of the CNI lwi Collective. The CNI lwi Collective consists of:
 - (a) Ngati Tuhoe
 - (b) Ngati Manawa
 - (c) Ngati Rangitihi
 - (d) Ngati Tuwharetoa

- (e) Ngati Whakaue
- (f) Ngati Whare
- (g) Raukawa
- (h) The affiliate Te Arawa iwi/hapu
- 2. Kaingaroa Timberlands owns the Crown Forest Licences over Kaingaroa Forest and is the lawful occupier of the forest land. Timberlands Limited manages Kaingaroa Forest on behalf of Kaingaroa Timberlands. Timberlands Limited contracts FIRST Security Guard Services Limited (FIRST Security) for security work in Kaingaroa Forest and FIRST Security are authorised to issue trespass notices.
- 3. Under the Crown Forest Licences beneficial owners have certain rights of access. However such rights of access are subject to Kaingaroa Timberlands controls required for health and safety reasons (Kaingaroa Forest is a multiple hazard workplace) and for protection of the forest assets.

Joint Access and Recreation Policy

4. CNI Iwi Holdings Limited and Kaingaroa Timberlands have a joint Cultural Access and Recreation Policy (Policy) for access to Kaingaroa Forest. The main provision of the policy is that:

All access to the land and forest requires an access permit from either Timberlands Limited or their contractor FIRST Security.

Currently beneficial owners or descendants are not required to pay to register for an access permit

Verification of beneficial owners or descendants

- 5. If you have been issued with a Trespass Notice and consider that you are a beneficial owner or descendant of the CNI lwi Collective noted in paragraph 1 above you may apply to your relevant Post Settlement Governing Entity to verify that you are a beneficiary owner or descendant.
- 6. Under the Policy, depending on the circumstances of the trespass KT, after consultation with representatives of CNI Iwi Holdings Ltd , may withdraw the Trespass Notice

Access Permits

- 7. Any access by vehicle or for hunting to Kaingaroa Forest is by a VALID access permit which can only be issued by Timberlands Limited or FIRST Security.
- 8. We are aware that a group is issuing permits to access forests. These are not VALID permits for access to Kaingaroa Forest and the use of these will result in a Trespass Notice.
