



## Kaingaroa & Rotoehu Hunting/Fishing Safety Snap Shot Photo Competition Terms & Conditions

1. Entry into this competition is deemed acceptance of the Terms and Conditions as set out in this document (**Terms and Conditions**).
2. Competition is limited to **1** photo per permit holder that has a current recreational permit.
3. By submitting a photo, you give permission to Timberlands Ltd to use the photo for any purpose, such as in promotional materials, publications, displays, and on websites, without compensation to or prior consultation with the photographer or, any related individuals. Photo credit will be given where possible.
4. The competition is open to all current recreational permit holders with the exception of any professional photographers and/or Timberlands Ltd employees and their immediate families.
5. To enter the competition, entrants must provide their full name, current permit number, valid email address, a hunting/fishing photo showing something related to safety, the photo's location and a short caption about the photo (**Eligible Entrant**).
6. Photos must be the property of the Eligible Entrant and must be of reasonable quality. By submitting a photo, you agree that any person(s) in the photo have provided their consent in allowing their picture to be entered into the photo competition and that such person(s) agree to these Terms and Conditions, in particular clause 2.
7. Competition commences on Saturday 23<sup>rd</sup> May 2020 and will close on the 27<sup>th</sup> September 2020 at 5pm. Three (3) winners will be selected and notified by the 9<sup>th</sup> of October 2020.
8. All photos must be taken in either Kaingaroa or Rotoehu Forests between 23<sup>rd</sup> May 2020 and 27<sup>th</sup> September 2020
9. The winners will be notified by phone or email. Inability to contact the winner within fourteen days of selection will result in the prize being forfeited.
10. The prizes consist of three (3) \$100 Hunting and Fishing Gift vouchers.
